Hi Aaron,

I was asked to compile for the Prosecutor's Office a listing of when BD spoke at PHM meetings and the number of videos he's made about PHM. Everything is online. I completed the tally on Thursday & forwarded it on.

- **BD spoke at a total of 22 Board meetings from 11/8/21 - 9/11/23.** Sometimes he spoke more than once--on an agenda item(s) and in Hearing of Visitors. They're all archived on PHM's YouTube channel (<https://www.youtube.com/@PennHarrisMadison/streams>). I have the full list with the time codes he spoke so they can be viewed.
- Including the threatening video towards PHM & Board Pres. Chris Riley he posted to YouTube on Sept. 15, 2023 that led to his NTO, **BD has made a total of 80 videos released between 11/14/21 - 10/21/23.** The videos were about PHM Board Members, PHM teachers and staff, retired PHM teachers, other PHM parents, and PHM students. The vast majority are on his YouTube channel (<https://www.youtube.com/@BensRantNation/videos>). The 9/15/23 video and two others have since been removed, but I had record of them in other ways.
