Portage and Warren boards vote for new fire territory, increasing pay (southbendtribune.com): Former local Democratic party head and Portage Township Trustee Jason Critchlow won approval for the creation of a new fire territory empire -- which he has named, with high expectations, The St Joseph County Fire Territory. Critchlow is merging Portage and Warren's fire services, which means a new tax on the less-affluent houses in his newly created district. The tax will affect only households below \$110,000. If Critchlow continues to expand -- as is his intention -- expect even more tax hikes. As attorney Pete Agostino said: "If you're taking on an area that's lacking service where you're going to provide more service, then you're going to have an increase."

New apartments and hotel near Memorial Hospital in downtown South Bend (southbendtribune.com): And here is yet another reason Mayor Mueller and his staffer Caleb Bauer are working so hard to keep a homeless center out of downtown -- and on the city's far west side outskirts. They want to reserve their core downtown for economic development. So, while Mueller wants residents on the edge of the city to "bear the burden," he wants to make sure his downtown economic sector does not. "All told, the north side of downtown is set to garner more than \$334 million of private investment and about \$36 million of public money....In a conservative estimate, city officials said, the Madison Lifestyle District will pay \$2.2 million in annual property taxes. Right now, those two blocks are "a sea of parking" contributing little to city coffers, according to Caleb Bauer, executive director of South Bend's Department of Community Investment...Interest in the site grew after Memorial Hospital publicly announced its plans for a new patient tower two years ago. Anticipating the need to hire hundreds of new employees, hospital leaders were eager to support hundreds of new housing units right next door..."

South Bend Mayor James Mueller discusses Clerk Office backlog, New Day Intake Center (wsbt.com): On Wednesday, the Mayor appeared on WSBT claiming he is still hopeful the city will find a better site for a new low-barrier

homeless center than the Bendix Drive site in Councilman Joe Thomas's district, which is surrounded by residences, businesses, a school and a daycare. He says he has one or two months before he has to pull the trigger -- but, for now, he says, all he has is Bendix. This is despite attempts made by businesses in the community who came forward with a hearty list of alternative options. Mueller's ultimate goal: keep low-barrier homeless centers out of downtown.

Indiana gubernatorial candidates grade Holcomb in FOX59/CBS4 debate (southbendtribune.com): When former Indiana Economic Development Corporation head and governor candidate Brad Chambers gives Gov. Holcomb an A, you know this ultimate Indy insider (who is most definitely not an "outsider" like he claims) is not the man for the job. Lt Gov and Gov candidate Suzanne Crouch gave Holcomb a C for Covid, A on the economy. Former AG and gov candidate Curtis Hill -- not allowed to participate in the debate, because of not-high-enough poll numbers, said he would give Holcomb a D or an F.

Local leftist and candidate vying for state rep Dale Devon's spot, Heidi Beidinger, had this to say about AG Todd Rokita's new report on the state's faulty Covid data: "This is such @\$\$. The only thing inflated is his ego. What is he really trying to accomplish with this parlor trick? Because i'm sure it has nothing to do with COVID." Sounds about exactly what you would expect Heidi to say!

Expert pushes back on attorney general's report on COVID-19 data, says it lacks context – Indiana Public Radio: *"The Regenstrief Institute worked with public health and health care agencies to gather and communicate data in the early days of the pandemic. Brian Dixon, the director of public health informatics at Regenstrief, said there were in-depth discussions around those public policy decisions and what data should be considered..."* Criticizing Rokita's report, Dixon went on to say: *"It hasn't been peer-reviewed or vetted by any other source," Dixon said. 'I would say that particular analysis only looked at data from the first couple years of the pandemic.' He said researchers have had time to look at non-pharmaceutical interventions, such as masks and 'Stay-At-Home' orders; there have been a number of studies that have identified their benefits."* Rokita's response: "It comes as no surprise that Regenstrief is defending Indiana's COVID-19 data when their own dashboards are so closely tied to the faulty data identified in our report."

Indiana GOP To Let Dems Kick Any Republican AG Off The Ballot (thefederalist.com): Speaking of Rokita, do you remember this piece that highlighted how super political the supposed disciplinary board is that is investigating Rokita? Add to the story, now, that one of the disciplinary board members -- Bernard Carter -- is the host of a "Meet and Greet" (and likely fundraiser) at a country club event for Destiny Wells, Rokita's Democrat opponent.
