



As you can see on the back page of John Klaassen's CAN-34 (exhibit A, B, C), the Candidate Name Information has not been filled out on any of the 3 that were turned in. This MUST be filled out on at least one CAN-34 for a candidate's name to appear on the ballot. It states on the form that if it is not filled out, it is a challengeable offense and it would mean that "no name" will appear on the ballot. In both the CAN-34 for David Pine (exhibit D) and for Aaron Byerly (exhibit E) they are filled in correctly and completely.

Along with the Candidate Name Information, John Klaassen did not have his Candidacy Consent notarized on any of the 3 pages submitted. Thus, making the whole candidacy filing invalid. Once again, see exhibit A, B, and C and compare it to both David Pine (exhibit D) and Aaron Byerly (exhibit E) in which both these candidates took the paperwork to a notary and had it completed properly.

Both omissions are a violation of IED laws and make this candidacy void. Hence John Klaassen should not be allowed on the ballot for the 2024 general election.


