

As you can see on the back page of Joel H Lash's CAN-34 (exhibit A), the Candidate Name Information has not been filled out. This MUST be filled out for a candidate's name to appear on the ballot. It states on the form that if it is not filled out, it is a challengeable offense and it would mean that "no name" will appear on the ballot. In both the CAN-34 for David Pine (exhibit B) and for Aaron Byerley (exhibit C) they are filled in correctly and completely.

Along with the Candidate Name Information, Joel H Lash did not have his Candidacy Consent notarized making the whole candidacy filing invalid. Once again see exhibit A and compare it to both David Pine (exhibit B) and Aaron Byerley (exhibit C) in which both these candidates took the paperwork to a notary and had it completed properly.

Both omissions are a violation of IED laws and make this candidacy void. Hence Joel H Lash should not be allowed on the ballot for the 2024 general election.




